FARAWAY, SO CLOSE – 25th Biennial of Design (BIO 25) in Slovenia: Call for Participation

The Museum of Architecture and Design (MAO) has launched **an open call for participation** in FARAWAY, SO CLOSE – 25th Biennial of Design (**BIO 25**), curated by Angela Rui and Maja Vardjan.

The call is dedicated to designers, architects, filmmakers, graphic designers, interaction designers, illustrators, writers, animators, photographers, researchers and other interdisciplinary agents who see the biennial as an experimental, collaborative platform for testing, developing and sharing their own approach and expertise within the issues and structure of the new biennial format.

The selected participants will work in teams, producing new scenarios based on frictions that emerge from the cohabitation of remote meanings and contemporary habits as emphasised in the curatorial statement. They will choose one team guided by Slovenian profile that is not involved with design or architecture, but is really interesting for his/her professional skills and by international designer or architect like Matali Crasset, Didier Fiuza Faustino, Mischer'Traxler, Formafantasma, Point Supreme, Odo Fioravanti or Studio Folder.

Rethinking "Laudato si": International seminar on Science and Religion cooperation for Environmental Care (ISSREC)

20-21 June, 2016 | Torreciudad Shrine (located in the Pyrenees of Huesca, Spain)

The international seminar, led by Dr. Emilio Chuvieco and organized by the Environmental Ethics chair of University of Alcalá, the Tatiana Perez de Guzman el Bueno Foundation and the Social Promotion of Culture Foundation, aimed to foster the dialogue between scientists, theologians and religious leaders to promote a closer cooperation between sciences and religious traditions for environmental conservation.

The seminar was centered on the Pope Francis's encyclical *Laudato si'*, and the opportunities it opens to foster collaboration of world major religious traditions to mitigate environmental problems. Seventeen scientists, theologians and religious leaders from thirteen different countries and eight religious traditions participated in the seminar. The small number of invitees facilitated the informal and friendly dialogue between participants. No external public attended the meeting, but press conferences were held a few days before the seminar and one-day afterwards

ARCC 2017 CONFERENCE

Architecture of Complexity: design, systems, society and environment June 14-17, 2017 I Salt Lake City I University of Utah

Architecture is contextually contingent. Once the social, economic, and environmental networks and systems that presuppose architecture become a fundamental context for design, then the capability and culpabilities of architecture and its systems become newly, and more intensely, important. Ulrich Beck suggests that we are in a new phase of modernity in which architects' operations can be characterized by the development and implementation of contextual systems of increasing hazard. Our belief that society can control the dangers that itself produces is self-defeating. Ulrich suggests that we wrestle today with the side effects of yesterday's successes. How can we ensure a tomorrow that does not suffer from the same fate?

Systems thinking focuses on large-scale dynamic networks, rather than linear cause-and-effect relationships. In building, thinking systemically requires an equifinality approach: recognition that there are multiple ways to answer the problem of building, which lead in turn to different ways to organize design practice. Further, systems thinking uses multi-finality: recognition that similar initial conditions of cost, scale, and scope can yield widely different building results. This demands a broader understanding of what constitutes architecture. It demands a more systemic and holistic approach to the built environment.

Complicatedness is unforgiving in building, and the call for holistic thinking risks being inflated to an obtuse level where the system becomes an unmanageable mess of parts and relationships that become too untraceable to mean much of anything. As such, systems thinking in building practice requires defining the extent of the system – framing the inquiry to determine the specific parts, linkages, and networks. This makes architecture of complicatedness into an architecture of complexity. While complicatedness is confusing, alienating, and inefficient; complexity is rigorous, rich, layered, and meaningful.

The conference theme is the architecture of complexity. It seeks for the creation, clarification, codification and communication of research knowledge on architecture as design, systems, society and environmental networks. This call is for papers that span the modalities and domains of research, scholarship and creative work in architecture: history, theory, criticism, quantitative, qualitative, technical, applied, classroom, and practice. This is also a call for allied disciplines in planning, design, engineering and

business, as well as the physical and social sciences to ask questions and begin to answer why, what, and how of complexity in the built environment.
